Requirements:

1. Plumbing work must be applied by a Plumbing contractor **ONLY**, and be in accordance with the current 2015 IRC, IPC, IFGC and the NFPA 58 Codes.
2. Plumbing permits are required for the following:
Addition/Alterations, Accessory Structures, Equipment and Appliances.
3. Plumbing Contractor shall submit the following insurance: **General Liability, Workers Comp & Disability.**
4. Plumbing work for Generators can be applied by either the Plumber or Electrical Contractor however insurance shall be submitted by both contractors.
5. Plumbing permits are not required for kitchen & bath remodeling, or maintenance of existing plumbing.
6. Propane tanks shall be applied and permitted independent of any gas appliance, unless a plumber is installing both the tank and appliance.
7. Provide (2) copies of a recent property survey, clearly denoting the location of proposed equipment and/or appliance, and include required setbacks to all property lines. **NOTE: ALL** equipment and appliances (except pool equipment) shall be setback **100 feet** from every street line and at least **40 feet** from every other boundary line of the lot. For pools, all equipment/appliances, shall be setback **100 feet** from every street line and at least **50 feet** from every other boundary line of the lot. **Exception:** Propane tanks, oil tanks, generators or air-conditioning units, located within **5 feet** of the building they serve, may extend into the required setbacks.
8. Provide specifications for all proposed generators, boilers, pool heaters and radiant heat systems.
9. Provide plumbing schematic for all proposed gas lines, equipment and appliances for interior & exterior.
10. **If you have a water well on the property, underground propane tanks must be located 100 feet away from any water well as per SCDOH. Wells must be located on a survey or NO PERMIT will be issued.**

FEES: (add \$100 CO/CC fee to each application)

Underground Propane Tanks: \$350 for 1st tank, \$25 each additional, includes all exterior gas lines.

Aboveground Propane Tanks: \$250 for 1st tank, \$25 each additional, includes all exterior gas lines.

Abandonment/Removal: \$250 for 1st tank & \$25 ea. additional, \$150 if included w/additional utilities

Oil Tank: \$250 for 1st tank, \$25 each additional, \$150 if included w/abandonment

Oil to Gas Conversion: \$250 includes NG line, boiler & HW heater

Oil to Gas Conversion w/propane tank/s: \$500 w/1st tank, \$25 each additional LP tank

Generator: \$350 / **Generator w/propane tank/s:** \$500 w/ 1st tank, \$25 each additional tank

Interior Gas Fireplace: \$250 for 1st FP & \$25 each additional

General Plumbing Fee: \$250 min. for any item not listed above.

*** GAS LINES ARE INCLUDED FOR ALL APPLIANCES AND EQUIPMENT**
(unless an individual gas application is submitted, then the general plumbing fee applies)
