2026 HARBOR USE PERMIT

Enclosed are the Harbor Use Permit application and summary of the regulations for operation of vessels in Lloyd Harbor.

Please note that **all vessels** moored, anchored, or rafted with other vessels must have a current Harbor Use Permit decal displayed at all times. You will be issued two decals with the same number. One decal must be placed on the upper part of your buoy and the other decal must be placed on your boat.

****NEW FOR 2026** – YOU ARE REQUIRED TO PROVIDE ONE OF YOUR PERMITS TO YOUR MOORING CONTRACTOR PRIOR TO THE INSTALLATION OF YOUR MOORING. MOORING CONTRACTORS ARE PROHIBITED FROM PLACING ANY MOORING IN THE WATER UNLESS A VALID PERMIT DECAL HAS BEEN AFFIXED TO THE BUOY.**

Please note that vessels attached to yacht club or other boating association moorings are not required to display a Harbor Use Permit decal; however, they must fly the club burgee. A maximum of 13 Club Permits will be issued.

Harbor Use Permits are issued on a first-come, first-served basis. There is a limit on the maximum number of permits issued. Therefore, it is suggested that you renew without delay. Please be advised that operators of vessels who have failed to answer a summons for infractions of the Village Code Chapter 71 (Boats and Boating) will not have their permits renewed or be issued a new permit.

Note: Non-residents may apply for up to two affiliate permits for a \$50.00 fee for each affiliate permit. Affiliates must complete an application and will receive an affiliate Harbor Use Permit, which may be used in conjunction with the non-resident's mooring. Affiliates must place one decal on the non-resident's mooring and the other on their boat.

Failure to affix the Harbor Use Permit decal to both the buoy and the moored vessel will result in citation and/or removal of mooring gear.

I am required to provide one of my permits to the authorized mooring contractor listed below prior to the installation of my mooring. I understand that mooring contractors are prohibited from placing my mooring in the water unless my valid permit decal has been affixed to the buoy.

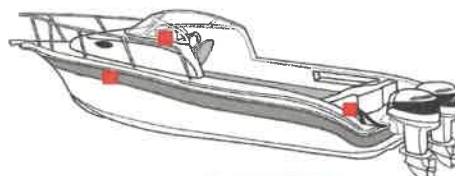
APPROVED VESSEL DECAL LOCATIONS

The Harbor Use Permit decal must be placed in one of the following approved locations on your vessel:

1. **Adjacent to the state registration numbers**
2. **On the side windshield**
3. **On the transom**

These are the only approved locations for vessel decal

placement – **The decal must be visible at all times.** Please select the most appropriate location taking into consideration any mooring covers that may obscure your permit.



REGULATIONS FOR OPERATION OF VESSELS IN LLOYD HARBOR

To ensure safe and equitable use of Lloyd Harbor waters, the following regulations are in force:

- a. The Harbor is divided into a Channel, two Mooring Fields, a Transient Anchorage, a Ski Area, and the Inner Harbor as shown on chart.
- b. All vessels over 16' in length that are anchored, and all vessels moored or rafted outside the Transient Anchorage, must display a current Harbor Use Permit decal. Boats without decals will be ticketed.
- c. No vessel may anchor or moor in the Channel or Water Ski Area, nor be on a mooring in the Transient Anchorage.
- d. A 5-knot speed limit applies everywhere except in the Water Ski Area when engaged in water skiing activities.
- e. Overnight occupancy is prohibited within 300' m.h.w. and west of the end of the Channel (in the Inner Harbor). Overnight rafting is limited to 3 boats on a mooring or anchor (no guests).
- f. Propulsion of any vessel except by hand or sail is prohibited within the Inner Harbor without a permit such as for a dock, mooring, shellfishing, etc.
- g. Any vessel anchored or on a mooring without visible evidence of a current Harbor Use Permit will be ticketed.
- h. Boats rafting on a club mooring will be limited to ten boats. Boats rafting on a resident/non-resident mooring will be limited to five boats, subject to weather, traffic, and Harbormaster discretion.
- i. Vessels on a club mooring are not required to have a Harbor Use Permit but must observe the overnight rafting limit and fly the club burgee.
- j. Lloyd Harbor is a New York State designated **"No Discharge Zone"** and marine sanitation devices must be secured to prevent discharge in the Harbor.

The Lloyd Harbor Harbormasters will monitor Channel 16 when on duty to respond to calls from vessels needing assistance.
