HIGHWAY DEPARTMENT



As the seasons change, and the leaves begin to fall, please note a few items.

The Highway Department does not collect yard waste, leaves, branches, etc. Removal & disposal of these things is the responsibility of the homeowner. Please do not blow the leaves from your property into the street and do not let your landscapers do this either. The dust cloud resulting from leaf blowing pollutes the air & the noise can be deafening. The Village noise ordinance prohibits the operation of machinery between the hours of 8:00 p.m. and 8:00 a.m. and on Sundays and legal holidays.



Supt. Schwarz is asking all private road associations to have the trees on their roadsides trimmed to provide the refuse trucks access and to keep the men on the tail gate from being hit by branches.



Plowing or depositing snow from private driveways or property onto the Village roads is illegal. The Highway Department would like to remind residents to refrain from plowing in this manner, especially after roadways have been cleared and snow has been pushed back behind the shoulders. This creates a dangerous driving situation and hampers their cleanup efforts. Residents violating this law will be issued fines.

Re: Deer Management

We write to inform you that, as in the past eight years, a deer management program will take place during the winter months of 2015. This program will be conducted in conjunction with cooperation from NYS Office of Parks, Recreation & Historic Preservation, the Seminary of the Immaculate Conception and the NYS Department of Environmental Conservation.

The deer population, unfortunately, has exploded and continues to be a matter of public health, safety and environmental degradation. We take this problem extremely seriously and have taken steps to put in place a multi-year rigorous program which, we believe, will result in a far more controlled situation. As in past years, all venison will be processed and donated to Long island food pantries, among them *Long Island Cares – The Harry Chapin Food Bank*.

Regarding the DEC hunting season, October 1 – December 31, 2014, please be advised that this season is fully regulated by the DEC (<http://www.dec.ny.gov/outdoor/hunting.html>). There are, however, Village safety and Lloyd Harbor Police notice requirements pertaining to same. The LHPD (631-549-8220) and Village Hall (631-549-8893) can provide you with a copy of these requirements. Should you hear or see anything of concern, please call the Lloyd Harbor Police. They will be able to advise you either that deer management is taking place or investigate, as appropriate.

E-WASTE

Effective January 1, 2015, it will be against the law to dispose of electronic equipment in your regular trash. Electronic equipment (including their cables, cords or wiring) covered by the new law include, **but are not limited to, VCRs, DVD players, digital converter boxes, cable or satellite receivers, electronic or video game consoles, televisions cathode, computers, monitors, electronic keyboard, fax machines, document scanners and printers.** For a more complete list of the types of electronic equipment covered by the new law, visit the NYS Dept. of Environmental Conservation's website at

You can either call the Highway Department at 631-549-8880 for a pickup, or drop off your e-waste at the

Town of Huntington Recycling Center

located at 641 New York Avenue, Huntington, NY.

The center is open through Saturday from 8 a.m. to 4 p.m.

There is no cost for the drop-off of e-waste.
