New Ordinances

Pursuant to appropriate notice & hearings, the following ordinances were enacted by the Board of Trustees:

Commercial Filming

This ordinance establishes regulations with respect to commercial filming on private property. There is a fee structure that covers LHPD patrol & oversight. A permit is required & can be obtained from the Village Clerk. Note: Filming related to the listing / sale of private property is exempt from these regulations.

Soliciting / Peddling

This ordinance establishes regulations with regard to obtaining a permit to conduct solicitation within the Village. There are robust permit requirements as well as a fee that must be submitted before a permit is issued. Permits can be obtained from the Village Clerk.

Dear Senator Gaughran,

I write on behalf of the Village of Lloyd Harbor to thank you for securing significant and most important grant funding, in the amount of \$200,000, for renovation of the Lloyd Harbor Police Department facilities. Our Village is one of the largest in New York State - roughly 10 square miles in area, 20 miles of shoreline, and 26 miles of public roads. However, more importantly with regard to our Police Department, Lloyd Harbor is home to Caumsett State Park, as well as a Huntington Town beach, and a Federal wildlife preserve, among several other entities with public entry. Caumsett State Historic Park alone attracts roughly 350,000 visitors per year, who live outside the Village. The LHPD handles all of this traffic and any related incidents. It is, therefore, a serious priority that the Police Department facilities be structured and equipped to handle this volume of traffic and activity.

On behalf of our Village, I am most appreciative of your Staff's assistance to Chief Krumpter's office during this grant process. I am, as well, most grateful to you for your very significant efforts in securing this funding for the Village of Lloyd Harbor.

Effective January 2, 2020:

Tri-stream recycling is in effect & <u>Glass</u> will now be collected each recycling day corresponding to your route

The following materials must be clean & In separate containers:

- 1. Commingled Recyclables: Plastic Bottles, Tin & Aluminum Cans No Plastic Bags, Styrofoam, Hangers, Paint Cans, Glass, Flower Pots, Toys
- 2. Clean Paper, Newspapers, Magazines & Corrugated Cardboard (flattened) No Wax-Coated Containers, Food-Stained Paper/Cardboard, Plastic Bags
- **3.** Glass: Household Bottles, Jars used for Food, Liquids, Beverages, Soda & Water *No Sheet/Window Glass, Light Bulbs, Mirrors, Ceramics, Drinking Glasses, Etc*

Please use Bins or Trash Cans for Separated Recyclables

DO NOT USE PLASTIC BAGS AS RECYCLING CONTAINERS

All other recyclables may be dropped off at the Huntington Recycling Center located at: 641 New York Avenue, Huntington, NY
