BOARDS & COMMISSIONS

Positions are available as follows:

•Board of Zoning Appeals- The BZA hears appeals for relief from the Zoning Code, as amended from time to time by local or state action. It also may hear and decide upon matters specifically referred to it by the Planning Board, and review any determination made by any code enforcement officer.

•Planning Board- The Planning Board handles all sub-division matters; waterfront construction including items such as docks, beach stairs, seawalls, revetments, etc. Items pertaining to the Village's extensive Master Plan also fall within the purview of the Planning Board.

•Site & Permit Review Board- The PRB (Permit Review Board) reviews all building permit applications for new construction, additions & alterations including renovations, remodeling & construction of accessory buildings. Installation of pools & buffer zone replanting are included in PRB review. Lot coverage, slope of land & tree removal, among other items, are also within the purview of the PRB.

CONSERVATION BOARD

Help avoid Deer/Vehicle Collisions!

- **Be Vigilant**: Make a habit of watching the sides of the road;
- Watch for Group Behavior: Deer tend to travel in herds. A lone sighting means others may follow. "Doe groups" are common in winter and often have fawns following them in the spring;
- Time of Day: Deer are most active at dusk & dawn. Be alert!
- Use High Beams: Use of high beams at night helps pick up "eye shine" of deer further along the road;
- The Big Slow-Down: This is your best defense against serious collision. It is far better than swerving or having to suddenly slam on the brakes, both of which can cause serious accidents.



POLICE DEPARTMENT

RAVE System

The Board of Trustees has authorized use of the "RAVE" system. This will take the place of "Code Red", the emergency notification system currently in place. The "RAVE" system provides notifications to registered Lloyd Harbor Village residents in the event of emergencies, storm-related information, road closures, search-related or other unusual aviation activity, etc. Notifications are sent immediately via method of choice: 1) Text Message 2) Email 3) Phone

You will need to register to receive "RAVE". Notification as to registration will be out soon. Contact information will be protected and the "RAVE" system used only for public announcements.

Governor's Executive Order Re: Police Reform & Reinvention

A meeting was held on Feb.17, 2021 pursuant to the Governor's executive order requiring each local government entity with a Police Dept. to "(1) perform a comprehensive review of current police force deployments, strategies, policies, procedures, & practices; (2) develop a plan to improve same if necessary. This plan must be adopted by April 1, 2021.



The Mayor & Trustees directed Chief Krumpter to oversee this extensive and exhaustive review. Invitees to the meeting included

"stakeholders" and representatives from the offices of Huntington Town Supervisor, Councilman Cuthbertson, the Suffolk DA and Senator Jim Gaughran attended. Mayor Thatcher welcomed the attendees, gave a short description of Village operations, thanked Chief Krumpter and asked him to comment on the exhaustive and comprehensive report. The report will be adopted at the March Board of Trustees meeting.

Raín Garden at Víllage Hall

A rain garden is a depression that captures & treats storm water by providing drainage & removing pollutants.

The Conservation Board has also long been interested in rain gardens for natural drainage control. Heavy rains consistently result in several feet of water flooding the field adjacent to the side parking area at Village Hall. An effective, natural and beautiful solution is a rain garden.

Many thanks to *Rusty Schmidt*, *Landscape Ecologist*, & *Cassandra Castano*, *Asst. Landscape Ecologist*, both of *Nelson*, *Pope Voorhis* for providing the beautiful design for our Rain Garden. In this 613 SF rain garden, we capture run-off from both the main road & field (about 15,000 SF area.) This allows an entire heavy rain event to be absorbed into the rain garden within 24 hours. Native plants tolerant of both wet and dry soils are used. These native plants have deep roots, allowing water to soak into the ground, and also provide habitat support and food for birds, bees and butterflies.
