### POOL REQUIREMENTS

1. **Pool Permit Application** – (1) original copy
2. **Permit Fee** - \$1,500 (includes fencing, attached spa, drainage, pool equipment, pool heater)
3. **CO/CC Fee** - \$100
4. **Pool Patio Fee** - \$0.50 per/sf
5. **Board Review** – \$250 Separate check (non-public unless otherwise noted)
6. **Tree Arborist/Landscape Architect** - \$200 (as determined by bldg. inspector for tree removal & review of any required landscape plans for screening)
7. **Contractor's Insurance shall be as follows:**
  - a. **General Liability Insurance** listing the Inc. Village of Lloyd Harbor including address as certificate holder, additional insured, and location of project in description area. Liability Insurance shall ONLY be listed on this certificate, workers' compensation shall not be listed or have value on this form.
  - b. **Workers' Compensation Insurance** NYS Form C105.2
  - c. **Disability Insurance** NYS Form DB120.1
  - d. **Contractor's License** Copy of license from Suffolk County Consumer Affairs
8. **Required Plans for In-ground Swimming Pools:**
  - a. Site plan including spot elevations (topographic survey required within slopes  $\geq 10\%$  over a 25x25 sf area) or as determined by the building inspector. Drywell design details and calculations for minimum of 3,000 gallon capacity for an average 20x40 pool and 4-inch rainfall for pool patio.
  - b. Three (3) copies of an existing survey within the past 5 years showing all current conditions. Scale shall be not less than 1"=40'.
  - c. Three (3) copies of Architect/Engineer construction plans signed and sealed to a scale not less than  $\frac{1}{4}" = 1'$ . Plans shall be size "D" 24x36 unless otherwise approved by the Building Inspector.
  - d. Pool framing plan & section for rigid wall designs including wall details. Plans shall be signed and sealed by an architect or engineer.
  - e. Pool Safety Notes & General Notes conforming to current 2020 NYSRC (New York State Residential Code.)
  - f. Longitudinal section, wall section & details including reinforcement, location of main drains, skimmers, returns, and pool depths.
  - g. Plumbing Schematic of all piping, returns, skimmers, main drains, pumps, heaters etc.
