### **2026 LLOYD HARBOR RESIDENT CAMP REGISTRATION WEEK INFORMATION**

**Dates:** Monday, March 2 - March 6, 2026

**Time:** 8:00 AM – 4:00 PM

**How:** Via drop box located outside of Village Hall.

**Payments:** Check or money order ONLY.

- Camp registrations (and any/all added camp weeks) received after Friday, March 6, 2026 will be considered late and subject to an additional \$50 per week, per child late fee.
- **REFUNDS & CAMP CREDIT WILL NOT BE GIVEN FOR ANY REASON.**
- **REGISTRATION FEE IS NOT REFUNDABLE AFTER A CHILD IS ENROLLED.**
- **WEEKS ENROLLED ARE NON-TRANSFERABLE TO OTHER CAMPERS.**

**SUMMER CLUB PROGRAM** (Children ages 6 – 10, entering Grades 1-5 in September 2026):

March 2 - 6, 2026: **\$395 per camper, per week.**

After March 6, 2026: **\$445 per camper per week.**

**JUNIOR RECREATION PROGRAM** (Children ages 10 – 13, entering Grades 6-8 in September 2026):

March 2 - 6, 2026: **\$500 per camper, per week.**

After March 6, 2026: **\$550 per camper per week.**

**CAMP DATES:** Monday, June 29 – Friday, August 21, 2026

**DAYS & HOURS:** Monday – Friday, 10:00 AM – 3:00 PM at Lloyd Harbor Village Park.

- Children must have the ability to function in an outdoor group setting with sandy, uneven terrain.
- Camp is not staffed to provide one-on-one attention.
- Please make sure your child is interested in and enthusiastic about these sorts of programs before registering.
- All activities depend on favorable weather conditions.
- There will be no camp held on inclement weather days.
- Inclement weather cancellations will be determined by 9:00 am.

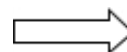

**Camp Drop-Off & Pick-Up Procedures**

**Drop-Off:** Drop-off time is 10:00 AM. You may drop off your child at the drop off area by pulling up to a staff member who will assist them in getting out of your vehicle on the passenger side only. If you prefer, you can also park your vehicle and walk your child to his or her assigned group.

**Pick-Up:** Pick-up time is promptly at 3:00 PM. You MUST park your vehicle and pick up your child from his or her assigned group. Children may NOT enter the parking lot area at pick-up unattended.

**Late Pick-Ups:** If your child is not picked up by 3:10 PM we will call your emergency contact. There is a \$30 fee for implementing the emergency contact list and you will be billed. If you are late more than 2 times there will be a \$50 fee and next year's camp registration will be held back until all other residents have registered. Failure to pay the fee will result in loss of camp registration privileges for the following year.

## Camper Conduct & Behavior Policy

It is our intent to keep all our campers safe and maintain a positive camp environment. Thank you for working with us to make the Lloyd Harbor Village Park Summer Camp the great experience it has always been for all of our children. We will not tolerate bullying, hitting or any other aggressive behavior. As such we are implementing a "Three Strikes" policy regarding violent, abusive and disrespectful behavior:

•First instance – Verbal warning from the child's counselor and a phone call from the Director to the parents to inform them of the offending behavior.

•Second instance – Camper will be removed from all camp activities, brought to the camp office and parents will be called to pick-up their child immediately. Offending camper will be suspended for the remainder of the camp day or the entire next day depending on the time of the offending behavior.

•Third instance – Expulsion from camp for the remainder of the season. Any remaining camp weeks will be forfeited and no refunds will be given.

We are confident that this policy will not have to be implemented and look forward to a rewarding and fun filled summer.

## Clothing and Equipment

- Sneakers and play clothes over a swimsuit.
- Water shoes (recommended).
- A towel.
- A life jacket (required for all Junior Recreation participants).
- A beach bag or other container, (please label all your child's belongings)
- A tennis racket & sneakers for tennis.
- Sunscreen.
- A lunch and a snack (if desired). Lunches can be refrigerated.
- Please send your child with adequate water every day.

*Please note: DO NOT bring cell phones, game consoles or music players to camp. The Village is not responsible for any lost, stolen or damaged personal belongings and strongly discourages these items being brought to camp.*

## **\*\*\*\*\*Important Information for Children with Life Threatening Allergies\*\*\*\*\***

**In order for the Health Care Designee to allow a camper to have medication such as an inhaler or Epi-pen administered, the specific camper must provide written orders from the licensed prescriber. These orders must list the camper's name, description of the use of the medication, the dosage of the medication, the route for administration, and the medication must be in its original container. Parental permission by itself is not sufficient. Without these orders in place, 911 will be called in the event of a medical emergency.**

**If an Epi-pen is administered during camp, 911 will be called for follow up treatment at the nearest hospital.**

## Additional Information

- Apply sunscreen to your child prior to camp each day. Counselors will reapply sunscreen during the day for younger children after their first swim session.
- We do not supply sunscreen.
- Check our "Lost and Found" located near the Drop-Off / Pick-Up area periodically.
- Provide your child with a bag lunch each camp day (except for Friday).
- Pizza Lunch will be served to all campers every Friday, please provide your child with adequate water. No glass containers please.
- Make your child's counselors and the Camp Director aware if your child has any special dietary restrictions such as Celiac Disease so we can best serve them.
- Label all of your child's belongings with his/her name.
- Make an effort to meet the staff members charged with your child's health & well-being while they are at camp. Parent/staff communication is a vital component to a positive camp experience.
- Campers are not permitted to walk home. A parent/guardian must be available to pick them up each day.
- Campers are not permitted to order food to the park. They must be provided with a bagged lunch with the exception of "Pizza Days".

## SUMMER CAMP PROGRAM DETAILS 2026

### SUMMER CLUB PROGRAM (for children entering Grades 1 - 5 in September 2026)

The “Summer Club” program provides our campers with a well rounded camp experience designed specifically for younger campers. Throughout the camp day, campers will take part in various fun activities. These include: swimming, recreational games, tennis, and arts & crafts. The program emphasizes building friendships and creating memorable summer experiences in a safe and supportive environment.

### JUNIOR RECREATION PROGRAM (for children entering Grades 6 - 8 in September 2026)

The “Junior Recreation” program provides many of the activities included in our “Summer Club” program but is tailored to our older campers with more advanced offerings. In addition to some of the activities offered through our “Summer Club” program, the “Junior Recreation” program introduces our older campers to exciting water-based sports such as kayaking, stand-up paddleboarding, wakeboarding as well as Pickleball. By providing a balanced mix of athletic and recreational activities, this program ensures that campers continue to grow, learn new skills, and form lasting friendships in a fun and active environment.

*Please make sure your child is interested in these types of activities prior to registering them for camp. While we want every child's camp experience to be a safe and fun one, please note that all activities follow a strict schedule that all campers are expected to adhere to and willingly participate in.*
