### REQUIREMENTS:

1. All tree contractors must be registered with the Village of Lloyd Harbor. No permit will be issued for an unregistered contractor. Contact the Village Clerk's office @ (631) 549-8893 for a copy of registered tree contractors.
2. All trees to be removed shall be marked with a **RED** ribbon only. **Ribbon available at Village Hall for \$2/roll.**
3. Applicant may only remove up to 12 trees with a circumference of 20-inches or greater within a 12 month period **ONLY**. Removal of more than 12 trees requires PRB approval (Permit Review Board Hearing)
4. Permit required for removal of more than **25 trees** (saplings) of less than 20 inches in circumference.
5. Tree removal is NOT part of construction, please **check box**
6. Provide a sketch on back of this form indicating location & size of trees to be removed.

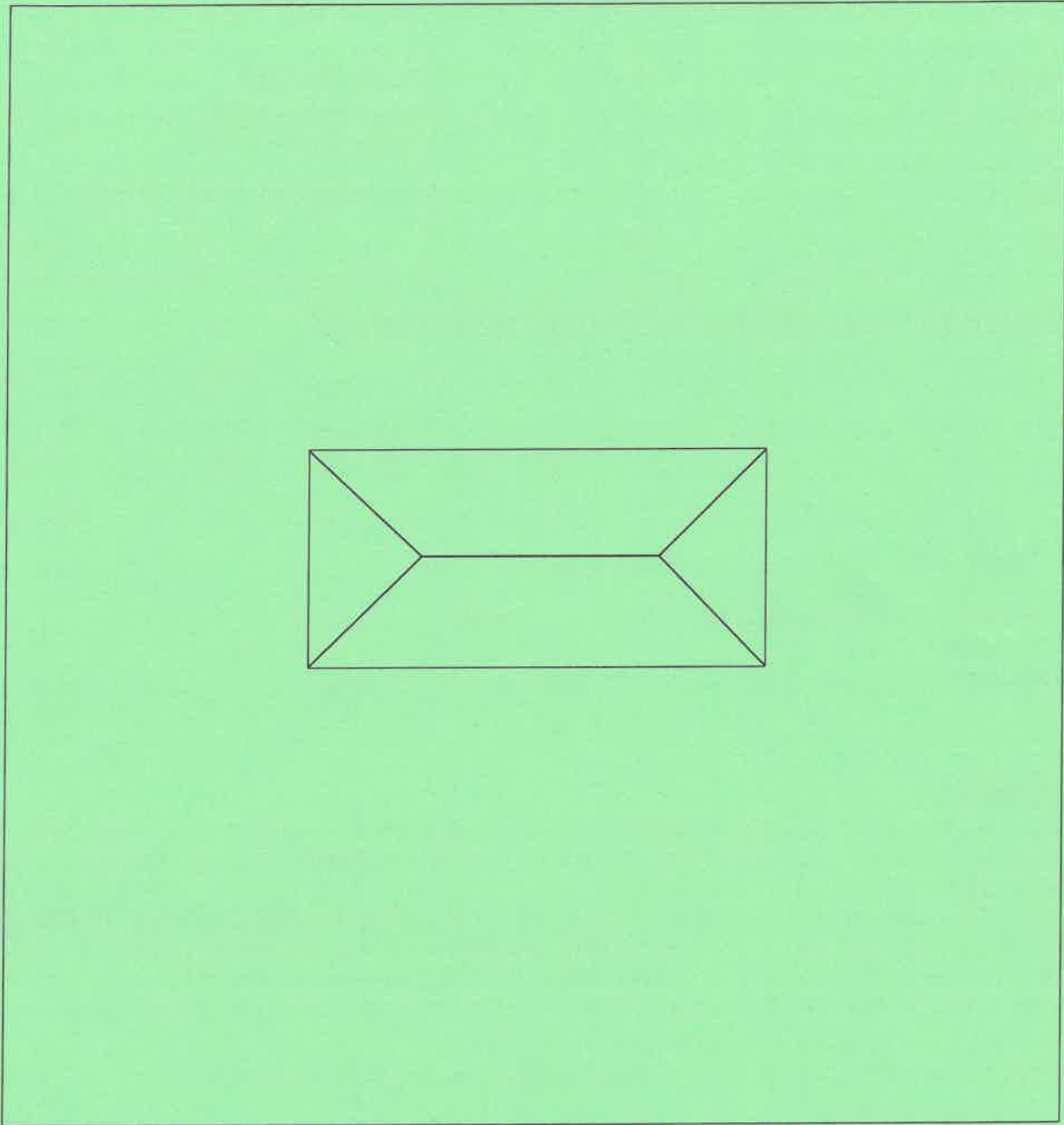
