The National Weather Service in New York NY has issued a Coastal Flood Warning, which is in effect from noon today to 3 PM EST this afternoon. A Coastal Flood Warning has also been issued from midnight tonight to 4 AM EST Tuesday. The Coastal Flood Advisory is no longer in effect.

LOCATIONS - Vulnerable coastal locales along western Long Island Sound.

TIDAL DEPARTURE - 2 to 2 1/2 feet above astronomical tides today, and 2 1/2 to 3 1/2 feet tonight.

COASTAL FLOOD IMPACTS - There is an elevated threat of property damage. Widespread flooding of vulnerable areas near the waterfront and shoreline. Expect 2 to 3 feet of inundation above ground level in low lying, vulnerable areas. This will result in numerous road closures and cause widespread flooding of low lying property including parking lots, parks, lawns and homes/businesses with basements near the waterfront. Vehicles parked in vulnerable areas near the waterfront will likely become flooded. Flooding will also extend inland from the waterfront along tidal rivers and bays.

TIMING - Around the times of high tide today and tonight.
